## MEMORANDUMAcademic Institutions with learners at Toronto RegionTO:Hospitals, Toronto Region HospitalsSUBJECT:Aligned approach in tracking and verifying learners' and<br/>instructors' COVID-19 vaccination status effective August<br/>24, 2021

On August 17, 2021, the Government of Ontario issued a <u>directive</u> mandating hospitals and home and community care service providers have a COVID-19 vaccination policy for employees, learners, and volunteers in high-risk settings. Such policy must require these individuals to provide one of the following: proof of full vaccination against COVID-19 or written proof of a medical reason for not being vaccinated against COVID-19. Proof of completion of a COVID-19 vaccination educational session may be required. Those not vaccinated must submit to regular point of care testing for COVID-19 and demonstrate a negative result, at intervals to be determined by the hospital, which must be at minimum once every seven days. These tests will be administered by the clinical site.

As such, a clear and harmonized approach that has consensus from the Toronto Hospital Education Table has been delineated.

As per the <u>Guidance on Tracking COVID-19 Vaccination Statuses of Learners</u> developed with consensus across the Toronto Hospital Education Table, the following will be <u>expected</u> and <u>assumed</u> for every learner and instructor that academic programs employ and send to hospitals for clinical placements, effective August 24, 2021:

- The academic institution ensures the learner meets placement eligibility criteria, as defined by placement site.
- The academic institution collects, collates, and keeps record of proof of COVID-19 vaccination for learners and instructors who are vaccinated.
- For those who are not vaccinated, the academic institution collects and collates proof of medical reason for not having vaccination, and/or completion of COVID-19 vaccination educational session as part of learner registration.
- If the learner is not vaccinated, the academic institution will contact the hospital on the approach to this learner's placement on a case-by-case basis. The same conditions apply to instructors from the academic institution who teach at the clinical site.
- Hospitals may contact the academic institution to verify a learner's COVID-19 vaccination status or proof as appropriate and on a case-by-case basis. The same conditions apply to instructors from the academic institution who teach at the clinical site.
